CHAIR'S MESSAGE



Dear Colleagues,

As the new Chair of the IRCEP Steering Committee, I'd like to welcome you to the Fall 2013 IRCEP Newsletter. These are exciting times for IRCEP. We are beginning to see significant progress in our effort to encourage excellence in the education and training of counsellors worldwide. In this edition of the newsletter, I would like to highlight some of the progress and changes.

The most significant change for IRCEP has been Becky Stanard's retirement as Chair of the IRCEP Steering Committee. As many of you know, Becky's contribution to IRCEP cannot be overstated. Along with the CACREP Board, Becky took an idea for an international registry of counsellor education programs and made it real. When IRCEP began, Becky was a committee of one. She worked with the CACREP staff to recruit a steering committee and in 2009 at the initial Steering Committee meeting in Argentina, IRCEP became a reality. Becky's efforts since that time have been tireless. Over the last year, 37 CACREP accredited programs have been added to the Registry. Becky's efforts also resulted in the registration of the first counsellor education program outside the US. Over the last four years, Becky's name has been synonymous with IRCEP. While I don't think I can begin to fill her shoes, I am grateful that she will continue to be involved with our effort to promote our profession on a global level.

IRCEP has also made some organizational changes based on our experience with promoting the registry that we believe will enhance our ability to work more closely with international counselling programs to help them understand and complete the application process. In order to streamline and facilitate work among steering committee members, we have reduced the committee to five (5) members and for the purpose of enhancing communication with interested programs and applicants we have created the role of IRCEP ambassadors who will be available to individually consult with these programs. We are excited about these changes and view them as an important step furthering IRCEP's vision of creating a vibrant and dynamic international registry.

There has been a flurry of activity since our last newsletter. We added Centro Argentino de Psicología Humanística y Counseling Holos-San Isidro to the Registry and we are currently reviewing Veer Bahadur Singh Purvanchal University (VBSPU) in India that has completed the application process. In

Registry Decisions

IRCEP is excited to announce that its first international program, Centro Argentino de Psicologia Humanistica y Counseling Holos-San Isidro in Argentina, successfully completed the IRCEP review. Holos San Isidro was the first school of counseling in Argentina when counselling was approved by the Ministry of Education as a career. The program trains professionals in the discipline of counselling from the Person-Centered Approach and Humanistic Psychology. Students who graduate from this program are awarded a certificate of Consultor Psicologico Counsellor and are licensed to practice counselling in a variety of settings.

Individuals from BACP, NBCC, CACREP and ACA will serve as organizational liaisons (non-voting members) to the committee. In response to the growing number of requests from programs, IRCEP has created a new group of participants who will serve as ambassadors/consultants. These individuals will be asked to assist programs in completing their applications and/or reviewing completed applications.
