

# Accreditation Decisions

---

Listed below are the accreditation decisions made by the Council for Accreditation of Counseling and Related Educational Programs (CACREP) at the July 13-15, 2017, meeting of the Board of Directors. The accreditation decisions made at this meeting were based on each program's level of compliance with CACREP's Standards for Accreditation. The next meeting of the Board of Directors is scheduled for January 2018.

CACREP accreditation is voluntarily sought by education programs offering [entry-level master's degrees in counseling](#) and/or doctoral degrees in counselor education and supervision. Programs that have completed the accreditation review process, whether for the first time as an initial accreditation review or as a re-accreditation review, can receive one of three basic decisions. These decisions then become the accreditation status of the program. The three categories of decisions are the following:

1. Accredited for an eight-year period: This status is granted to programs that, in the professional judgment of the CACREP Board of Directors, meet all standards in a satisfactory manner.
2. Accredited for a two-year period: This status is granted to programs that substantially meet the requirements for accredited status, but which need to address relatively minor standards-related deficiencies. The CACREP Board of Directors confers two-year accreditation to a program when there is a belief that the program can correct the deficiencies within the two-year period. Within the two-year period, the program is required to submit an Interim Report providing the requested information. Acceptance of the Interim Report will lead to accreditation for the remainder of the eight-year accreditation cycle.
3. Denial of accreditation: Accreditation is denied when, in the professional judgment of the CACREP Board of Directors, the counseling program specialty has been unable to establish clear evidence that it is in substantial compliance with the standards.

In addition to making decisions in the above three listed categories, the CACREP Board may be requested to take action on requests made by programs currently accredited. These actions may occur in the following categories:

Dual Accreditation as CMHC/CLRC – Programs that are accredited as Rehabilitation Counseling programs by the Council on Rehabilitation Education (CORE) can apply to have their programs evaluated by CACREP and CORE against both the Clinical Mental Health Counseling (CMHC) standards and the Clinical Rehabilitation Counseling (CLRC) Standards.

Voluntary Withdrawal of Accreditation Status – CACREP Policies Governing Timelines 2.e – *Voluntary Withdrawal of Accreditation Status* allows programs to withdraw from any accreditation status at any time during the review process or during an accreditation cycle. Programs that choose to voluntarily withdraw must notify CACREP in writing of this decision. It should be noted that withdrawal is a voluntary action taken by the program.
