FROM THE CHAIR

The primary purpose of the CACREP meeting was to review program accreditations and to discuss CACREP core values. Three work groups identified a series of core values which are being fine-tuned by the board members and which

CACREP Does it's Own Self-study

It's payback time in the CACREP office. In March 2002, CACREP will undergo a review by the Committee on Recognition of the Council for Higher Education Accreditation (CHEA). We had to submit a self-study with evidence that CACREP meets all of CHEA's recognition criteria. This will be our first review since CHEA was created. Formerly, CACREP was recognized by the Council on Recognition of Postsecondary Accreditation (CORPA).

CHEA invites comment from third parties as part of it's review process. All third parties who wish to provide comment on CACREP's recognition review must submit in writing to CHEA a description of the organization(s) they represent and an outline of the proposed comments. All comments must address CACREP's efforts to meet the CHEA recognition criteria. Third party comments must be received at the address below by February 1, 2002.

Does CACREP Accredit Combined Programs?

In the past five years, CACREP has witnessed the development of combined and/or dual degree programs. The development of these programs appears to be a market and student driven phenomenon, based on students' beliefs that dual degrees in both school counseling and mental health or community counseling will provide them with greater employment options upon graduation. This idea is hard to dispute. But what does the creation of the "super counselor" program mean for program identity, for professional identity, and for meeting accreditation standards? These are the questions that CACREP has had to deal with when combined programs have approached us for an accreditation review.

In CACREP's experience, the combined program often presents the following scenario.

For years, our department has offered master's degree programs in school counseling and community counseling at the 48 semester hour level. We have recently upgraded our curriculum to require a minimum of 54 hours for the degree in community counseling. The feedback we have gotten from our students is that they would be willing to take a 60 semester hour program if it would give them the option of seeking both licensure as an LPC and certification as a school counselor in our state. Since both programs essentially require the same common core curriculum, we see this as possible and would like CACREP's consideration of accrediting this combined program so that students could call themselves graduates of CACREP accredited programs in both areas. We know that internship experience is requirement in both areas and feel that splitting the internship into two 300 clock hour experiences- one in the school and one in a community agency- will meet the standard. Your feedback on this structure will be appreciated.

CACREP's response might look something like this.

First, it is important to note that CACREP does not currently accredit combined or dual degree programs. If you apply for accreditation of the combined program at this time, you will need to choose one program area. For example, if you implement the 60 hour program, you could apply for accreditation review as simply a community counseling program.

Second, should you receive accredited status for this program, you may only represent this program as being accredited under the selected program title under which you were reviewed by CACREP.

Third, if this program were to become a CACREP accredited community counseling program and graduates of this program desired to seek state certification as a school counselor, your faculty may sign off or indicate that the students have met the state's requirements, but you may in no way indicate that they have met CACREP's school counseling requirements.

With regard to internship requirements, CACREP Standards call for each accredited program area to offer a minimum 600 clock hour internship (for Mental Health Counseling programs, a minimum of 900 clock hours is required). Therefore, your proposal for the combined program to offer only one 600 hour internship split between a school and community agency setting would not be acceptable. A community counseling program would need to offer the internship in a community (not school) setting under the supervision of an individual with a minimum of two years of professional experience in the program area. If CACREP were ever to decide to accredit a combined program under two program area titles, it would most likely require a 600 hour internship in each of the areas. In previous discussions, the Board has indicated that this would be important for maintaining the integrity of the Standards and for insuring that graduates were adequately prepared to practice in either setting.

In closing, while CACREP has not yet accredited a combined program, the Board recognizes that changes in the profession may modify future program offerings and program structure. CACREP may also decide that its accreditation model must change to accommodate new program models, such as combined or dual degree programs. However, the choices to be made must always give consideration to maintaining respect for appropriate professional identities while preserving quality preparation requirements for the program areas involved.
