

Regional Accreditor Teach-out Policy

Institutions have an option to enter into a teach-out plan with the approval of their regional accreditor even if there was no articulation agreement with Argosy University prior to its closure. A teach-out provides students benefits that a regular transfer does not. These benefits include: acceptance of all credits earned and the counting of those credits towards a certificate or degree from the receiving institution.
