

Accreditation Decisions

Listed below are accreditation decisions made by the Council for Accreditation of Counseling and Related Educational Programs (CACREP) at the July 11-13, 2019, meeting of the Board of Directors. Accreditation decisions made at this meeting were based on each program's level of compliance with the CACREP Standards. The next meeting of the Board of Directors is scheduled for January 2020.

CACREP accreditation is voluntarily sought by education programs offering [entry-level master's degrees in counseling](#) and/or doctoral degrees in counselor education and supervision. A program completing the accreditation review process, whether for the first time via an initial accreditation review or via a re-accreditation review, can receive a decision in one of three categories. These decisions determine the accreditation status of the program. The three categories of decisions are:

1. Accredited for an eight-year period: This status is granted to programs that, in the professional judgment of the CACREP Board of Directors, meet all standards in a satisfactory manner.
2. Accredited for a two-year period: This status is granted to programs that substantially meet the requirements for accredited status, but which need to address relatively minor standards-related deficiencies. The CACREP Board of Directors confers two-year accreditation to a program when there is a belief that the program can correct the deficiencies within the two-year period. Within the two-year period, the program is required to submit an Interim Report addressing the standards-related deficiencies.
3. Denial of accreditation: Accreditation is denied when, in the professional judgment of the CACREP Board of Directors, a counseling program or one or more of its specialty areas has been unable to establish clear evidence that it is in substantial compliance with the standards.
