# Results from a National Survey of Accredited Programs

#### INTRODUCTION AND OVERVIEW

The CACREP Vital Statistics Survey is used for collecting more detailed program information and soliciting feedback from accredited programs on current issues. The survey results are also used by the CACREP Board of Directors and staff to help improve the services provided to accredited programs.

CACREP program liaisons are charged with reporting data on the Vital Statistics Survey each academic year, including the summer, fall, and spring academic terms. The 2023 CACREP Vital Statistics Survey collected program data covering July 1, 2022, through June 30, 2023. This data is used to monitor changes and emerging trends within counselor education programs.

The purpose of this report is to make the results of the 2023 CACREP Vital Statistics Survey available to CACREP-accredited programs, state and federal government agencies, counseling licensure/certification entities, counseling researchers, and other stakeholders within the counseling profession as well as the public. Data concerning CACREP programs, specialty areas, faculty members, and students are presented along with brief narratives as appropriate. The information in this Vital Statistics Survey results report offers a unique description of currently accredited counselor education programs—as well as the students they serve—which assists in providing an environmental context that is helpful for understanding counselor preparation in 2023.


#### INSTITUTIONAL INFORMATION

All graduate counseling programs accredited by CACREP before July 2023 completed the 2023 Vital Statistics Survey. As a result, 445 institutions offering a total of 951 CACREP-accredited counseling degree programs contributed to the data included in this report.

#### **INSTITUTION TYPE**

CACREP accredits graduate counseling programs at all types of post-secondary institutions (see FIGURE 1). Using categories set forth by federal guidelines, institutions offering CACREP-accredited counseling programs in 2023 are broken down as follows: Public (n=251), Private not-for-profit (n=186) and Private for-profit (n=8).

### INSTITUTIONS BY STATES/TERRITORIES

According to the 2023 Vital Statistics Survey results, CACREP-accredited programs employ 3,725 full-time faculty members and are offered by post-secondary institutions located throughout the United States. To present a clearer geographical picture, these institutions are categorized by their location within each state or territory (see TABLE 1). In 2023, the five states with the highest concentration of institutions with CACREP-accredited programs were Texas (n=35), Pennsylvania (n=25), New York (n=24), Illinois (n=23), and Ohio (n=20). The states of Alaska, Delaware, Vermont, and Wyoming each included a single institution (n=1) with a CACREP-accredited program.

#### CACREP PROGRAM AREAS

Clinical Mental Health Counseling was the specialty area with the highest number of CACREP-accredited programs (n=399) in 2023, with School Counseling programs having the second most (n=276). The CMHC specialty area is likely to continue to grow as Community Counseling and Mental Health Counseling programs under the 2001 Standards are combined while they transition into Clinical Mental Health Counseling programs under the 2009 Standards. School Counseling programs experienced the second highest increase (n=9) in growth last year while several other specialty areas increased slightly that include Addiction Counseling (n=2), Clinical Rehabilitation Counseling (n=1), Counselor Education and Supervision (n=7), and Marriage Couple and Family Counseling (n=2). However, two specialty areas experienced a slight reduction in numbers of programs last year that include Rehabilitation Counseling (n=5) and dually-accredited Clinical Mental Health Counseling and Clinical Rehabilitation Counseling and Clinical Rehabilitation Counseling is expected due to the time-limited availability of this accreditation option. This trend will continue until the time this accreditation option expires on October 31, 2024.

In terms of graduates in the past year, Clinical Mental Health Counseling programs claimed the most with 13,648 graduates. The Clinical Mental Health Counseling specialty area also claimed

the largest number of currently enrolled students (n=56,879) in 2023. Specialty areas that reported fewer than 100 students enrolled, as well as less than 100 graduates, in 2023 include: Career Counseling, Addiction Counseling, and Student Affairs and College Counseling. TABLE 2 offers further details on the number of accredited programs, student enrollment, and graduates reported by program area.

TABLE 3 sheds light on the number of individuals who applied to CACREP programs in the past year, the number of students who graduated from CACREP programs in the past year, and the total number of students currently enrolled in CACREP programs across the country, per the 2023 survey. Information about total program applicants, graduates, and current student enrollments is broken down by program level (i.e., master's vs. doctoral) and data is provided for the past three years.

The aggregate applicant and graduate data for 2023 in TABLE 3 are based on programs report and reflect the total number of applications received and total number of students who graduated from programs "in the past year" (e.g., Summer 2022-Spring 2023). Current student enrollment is based on data reported by programs as of the date each program submits the Vital Statistics Survey for a given year.

#### **FACULTY AND STUDENTS**

Placing significant value on diversity, CACREP requires counseling programs to create and support an inclusive learning community. The CACREP Standards not only call for programs to recruit, employ, and retain a diverse faculty, they also require programs to make systematic efforts to attract, enroll, and retain a diverse student body. Part of examining diversity within the counseling profession involves taking a close look at the individuals who are becoming professional counselors. Going beyond numbers of applicants, graduates and student enrollments, this final section will provide a detailed demographic perspective regarding the makeup of full-time faculty members and students in CACREP programs.

Racial/ethnic demographic breakdowns are reported for full-time faculty members (TABLE 4), CACREP master's students (TABLE 5), CACREP doctoral students (TABLE 6), and all CACREP graduate students combined (TABLE 7).




